# Village Board Meeting Minutes April 4, 2011 Budget Public Hearing Organizational Meeting

# The Village of Caledonia Board of Trustees held a meeting on Monday, April 4, 2011 at 6:30 p.m. at the Village Office.

**2011-2012 Budget Public Hearing:** Clerk-Treasurer Ann Marie Grattan read the Notice of Public Hearing. Trustee Polo made a motion at 6:30 p.m. to open the Budget Public Hearing; Trustee O'Donoghue seconded the motion.

Overview of the General, Water & Capital Budgets. Purchases and projects are as follows:

Capital Budget:

° \$250,000 Business District Street Light Replacement Project

- The project will go out to bid in May.
- A \$60,625 down payment will be made.
- The rest will be paid up to a 5-year maximum plan.

Water Budget:

- ° A milling machine will be purchased with the Town of Caledonia; village cost \$6,000.
- ° Water equipment \$5,625
- ° Purification/Water testing \$2,600

° New hydrants, valve, parts/inventory, water meters, NYS Leak Detection & operating and maintenance fees \$29,400.

° Curb box repair \$10,000

General Budget:

<sup>°</sup> Reductions were made to 20 appropriations: Board Contractual, Court Contractual, Clerk Equipment, Clerk Contractual, Law Contractual, Village Buildings, Police Equipment, Street Equipment, Street Contractual, Snow Contractual, Sidewalk Contractual, Park Contractual, Youth Personnel, Recreation Personnel, Library Contractual, Museum Contractual, Beautification Contractual, Drainage Contractual, Publicity Contractual and Shade/Trees Contractual.

 $^\circ\,$  Reductions were from 8 to 100%. The average reduction was 50.1%.

° Garbage increased to \$6,000 for year two of the contract with LT Disposal.

° State Retirement increased approximately \$10,000.

- ° Police Retirement increased approximately \$8,600.
- <sup>o</sup> Health insurance increased \$8,000.
- ° New MacKay Park employee \$3,000.

° P/T Police was decreased to 21,840 from 44,590 last year to make room for an additional  $3^{rd}$  F/T Officer.

- ° Street Equipment \$11,950.
- ° Phase #1 of East Avenue reconstruction project \$84,000.
- ° Patching \$5,000, snow \$15,000, sidewalks \$4,000, parks \$5,000, shad/trees \$6,500.

The proposed tax rate will decrease to 8.95%, from 9.25%. The tax levy will stay the same.

Submitted was the Financial Report, which details general and water checking, savings and reserve cash available compared to last year. The Balance Sheets including a detail of revenues and expenditures to date was submitted for the General, Water and Trust & Agency accounts.
