The completion of the Grand Circle included topsoil and seeding. Equipment has been serviced to truck #3 and the leaf machine. Leaf pickup begins on October 17th. Daffies Pizza - Mr. Dean D'Agostino, owner of Daffies Pizza, spoke with the board regarding the purchase of his new location at 26 North Street. Mr. D'Agostino stated that the zoning has changed and he is looking for options to help him reopen the building as an existing restaurant. Village Attorney Jim Coniglio advised that the simplest way would be to amend the non-conforming use laws. A **motion** was made by Trustee Polo to amend the non-conforming use Law §215-67. The reference "when a non-conforming use has been discontinued for a period of not less than one year, it shall not be reestablished, and the future use shall be in conformity with the provisions of this

chapter" will be amended to include "without the intent to abandon, use may be permitted upon application to the Village Board." Trustee O'Donoghue seconded the motion.

Noise Ordinance – Frank and Beverly Ianiro of North Street discussed their problem with neighbors on LeHigh Street riding motorbikes in the backyard near their home. Mr. Coniglio distributed tonight New York State Vehicle and Traffic Law and New York State Penal Law. The village board should review these and discuss at the November 1st board meeting.
