WHEREAS, the Board of Trustees of the Village of Caledonia (the "Board") has been advised by the Village Justice Court (the "Court") that certain jury trials require that 12 jurors be empanelled pursuant to the New York State Criminal Procedure Law, and

WHEREAS, the Court has advised the Board that the primary Court Room in the Village Office lacks sufficient space to accommodate a jury trial in those cases where a 12 member jury is required (the "Trial" or "Trials"); and

WHEREAS, the Court has advised the Board that J.W. Jones Hall in the Village of Caledonia has sufficient space to accommodate such a Trial.

IT IS THEREFORE RESOLVED THAT:

1) J.W. Jones Hall is hereby designated as an alternate venue for the Court in such cases where the Court Room in the Village Office lacks sufficient space to accommodate any jury trial.
