**Resolution and Order Enacting Local Law 1, 2013 of the Code of the Village of Caledonia:** resolution was offered by Deputy-Mayor DiLiberto; with Trustee Polo moving for adoption:

RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF CALEDONIA TO SET A DATE AND TIME FOR A PUBLIC HEARING TO DETERMINE WHETHER A PORTION OF PHILMORE AVENUE SHOULD BE DISCONTINUED AS A VILLAGE STREET

Whereas, there is currently depicted on the official Village map a portion of Philmore Avenue which has never been opened, maintained or used as a Village Street for vehicular or pedestrian traffic; and

Whereas, the above depicted portion of Philmore Avenue is situated between Village tax parcel numbers 8.09-3-37 and 8.09-3-35; and

Whereas, the Village Superintendent of Public Works has determined that the above-referenced portion of Philmore does not serve as a right of way used by the general public; and

Whereas, New York State Village Law section 6-612 authorizes the Village to discontinue a street in the event such street no longer serves as a right-of-way to the general public; and

Whereas, New York State Village Law section 6- 614 requires a public hearing prior to a discontinuance of a public street by the Village the Board of Trustees.

Now therefore it is hereby resolved as follows:

- 1. The Village Board of Trustees shall hold a public hearing to determine whether the above-referenced section of Philmore should be discontinued as a public street.
- 2. A public hearing shall be held in Village Office at 3095 Main Street, Caledonia, New York 14423 on the 8<sup>th</sup> day of January, 2013 at 6:30 p.m.
- 3. At such time and place all interested parties shall be given an opportunity to be heard.
- 4. The Village Clerk is hereby authorized to publish a notice of said public hearing in the Livingston County News, the legal newspaper for the Village.
