## Village Board Meeting Minutes October 1, 2013

# The Village of Caledonia Board of Trustees held a meeting on Tuesday, October 1, 2013 at 6:30 p.m. at the Village Office.

**Members Present:** Mayor Joe Caluorie, Deputy-Mayor Scott DiLiberto, Trustee Jerry O'Donoghue, Steve Polo and Teresa Truman.

Present at tonight's meeting and surrounded by his loving family, was Don Manley who served this community for 50 years as a volunteer. Mayor Caluorie spoke of Don's accomplishments and life-long dedication to servicing the Caledonia community. Deputy-Mayor DiLiberto offered the following Resolution with Trustee O'Donoghue moving for adoption:

The program kicked off in March. Colon cancer screening at Noyes Hospital increased from 140 to 270 in March. The program will run again in March 2014.

**Wesley Ebersole, Boy Scout** – gave a power point presentation to the Village Board on Trigon Park. The park was cleaned, a new trail was made, mulch was spread and new plants were planted. Wesley has completed his project with the help of friends and community members. The Village Board thanked Wesley for his hard work.

Discussion on \$1,754 in additional aid received from the NYS. Trustee Polo questioned if the money should to be set aside for infrastructure improvements. Chris Buckley will make a list of projects so decisions can be made as to prioritizing projects. Clerk-Treasurer Ann Marie Grattan recommends the money go towards additional principal on the Street Light Ban in order to pay the balance off early and reduce interest

payments. In May of 2013, an additional \$10,000 in principal was made. In May of 2014, there will be another additional \$10,000. A **motion** was made by Trustee Polo for the Budget Amendment A3001 Per Capita and A9730.600 Bond Anticipation Note Principal, \$1,754; Trustee O'Donoghue seconded the motion. #### Ann Marie Grattan presented the Clerk-Treasurer Report for the month of

**September.** Presented to the Village Board for their review were the Budget Status Reports for General, Water and Trust & Agency funds, Department Reports, the Financial Report, Taxes Paid and Water Adjustment Report. A **motion** was made by Deputy-Mayor DiLiberto to accept the reports; Trustee O'Donoghue seconded the motion.

Tax receipt was mailed to the homeowner and marked paid due to clerical error. Therefore, the homeowner thought their escrow account made payment.

**Records Management** – Trustee Truman verified the annual destruction of records and signed the authorization form permitting the Clerk-Treasurer to dispose of certain items. A **motion** was made by Deputy-Mayor DiLiberto to accept Trustee Truman's audit of record destruction; Trustee O'Donoghue seconded the motion.

**Tax Resolution:** Deputy-Mayor DiLiberto offered the following resolution with Trustee Truman moving for adoption:

The resolution was unanimously adopted and will be filed with the Livingston County Treasurer and the Clerk of the Livingston County Board of Supervisors on October 2<sup>nd</sup>.

**Judge Mark Riggi presented the Annual Court Report and Audit.** Judge Riggi spoke of increases in court cases and arraignments. Also discussed was the \$21,397 in grants received by Court Clerk Julie Molisani from 2008 to 2012. Judge Riggi presented the 2013 grant:

**NOW, THEREFORE, be it resolved,** that the Caledonia Village Court is authorized to enter into a joint agreement with the Town of Caledonia Court for a grant,

Judge Riggi discussed the Annual Court Audit conducted by Trustee Truman on September 12, 2013. A **motion** was made by Trustee O'Donoghue to accept the audit and the annual report; Trustee Polo seconded the motion.

**Chris Buckley presented the DPW Report for the month of September.** Both bacteria water samples were negative. Hydrants were flushed and water meters read for quarterly billing. Installation of the new radio read water meters has begun. Topsoil and driveway restorations for Armstrong Place, Grand Circle and Stanton Parkway were completed. Help was provided to the Town of Caledonia to restore Black Street and Feeley Road. Equipment, park and building maintenance continues. A **motion** was made by Trustee Polo to accept the report; Trustee O'Donoghue seconded the motion. AYE: Deputy-Mayor DiLiberto, Trustee O'Donoghue, Polo & Truman NAY: None

A **motion** was made by Deputy-Mayor DiLiberto to pay Karen Polo as a vendor to update the village commons sign; Trustee Truman seconded the motion. Annual cost \$599.40.

**Dan Chapman presented the Police Report for the month of September.** There were 103 service calls, 33 traffic tickets issued, nine town assists, one accident report and five arrests. A free class is being offered in Niagara County on Officer Suicide. A **motion** was made by Trustee O'Donoghue to accept the report; Trustee Truman seconded the motion.

Discussion regarding the Crossing Guard Val Kay's salary. The salary was reduced from \$5,380 to \$3,000 annually due to the elimination of two daily bus runs at the school. Val submitted a letter for the boards review. A meeting will be scheduled with Chief Chapman, School Superintendent Bob Molisani and Tompkins Insurance to discuss crossing children, directing traffic and training issues. Trustee Polo suggested that full pay be reinstated for the remainder of the fiscal year retroactive back to September. The issue will be revisited after the meeting is held. A **motion** was made by Trustee Polo to increase the Crossing Guard pay to \$5,380 retroactive to September 2013; Deputy-Mayor DiLiberto seconded the motion.

#### Tom Perkins presented the Code Enforcement Report for the month of September.

Permits were issued for a porch, fence and hot tub. Completed projects included decks, a garage, solar roof mounted system, porch, basement egress window and fence. **Barry Ganzhorn presented the Matthews-MacKay Park Report for the month of September.** The Girl Scouts have approached Barry regarding a learning center project. More information will be provided at a later time. A willow tree was planted in memory of Chris and Emily Peterson. A dedication will be held this spring. **Local Law #2-2013** – a local law amending Chapter 215-4, rezoning lands known as McKay Park from Light Industrial (I-1) to Land Conservation (L-C).

The following resolution was offered by Trustee O'Donoghue with Deputy-Mayor DiLiberto moving for adoption:

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF CALEDONIA REGARDING ADOPTING LOCAL LAW NO. 2-2013 AMENDING SECTION 215-4 OF THE CODE OF THE VILLAGE OF CALEDONIA FOR THE PURPOSE OF REZONING LANDS KNOWN AS MACKAY PARK (PARCEL MAP NUMBER 7.7-1-64) FROM LIGHT INDUSTRIAL (I-1) TO LAND CONSERVATION (LC)

**WHEREAS,** a resolution was duly adopted by the Board of Trustees of the Village of Caledonia (the "Village Trustees") for a public hearing to be held by said Governing body on May 7, 2013 at the Village Office of Caledonia to hear all interested parties on a Proposed Local Law amending Section 215-4 of the Code of the Village of Caledonia for the purpose of rezoning lands known as MacKay Park (parcel map number 7.7-1-64) from Light Industrial (I-1) to Land Conservation (LC) (the "Project"); and

**WHEREAS,** notice of said public hearing was duly advertised in the official newspaper of said Village of Caledonia; and

**WHEREAS,** said public hearing was duly held on May 7, 2013 at 6:30 p.m. at the Village Office of Caledonia, New York, and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said Proposed Local Law, or any part thereof; and

**WHEREAS,** the Village Trustees forwarded a copy of the Proposed Local Law to the Livingston County Planning Board in accordance with GML §239-m; and

**WHEREAS,** by correspondence dated June 14, 2013, the Livingston County Planning Board recommended approval of the Project; and

WHEREAS, a resolution was duly adopted by the Village Trustees on September 3, 2013 declaring the Project as an Unlisted Action under Article 8 of the New York State Environmental Conservation Law and Regulations adopted pursuant thereto by the Department of Environmental Conservation of the State of New York (collectively, "SEQRA") and making a negative declaration for purposes of SEQRA; and

**WHEREAS**, the Village Trustees, after due deliberation, find it in the best interest of said Village to adopt said Proposed Local Law; now, therefore, be it

**RESOLVED**, that the Village Trustees hereby adopt said Local Law No. 2-2013 entitled "A local law of the Village of Caledonia amending section 215-4 of the Code of the Village of Caledonia for the purpose of rezoning lands known as Mackay Park from Light Industrial (I-1) to Land Conservation (LC)," a copy of which is attached hereto as <u>Exhibit A</u> and made a part of this resolution, and be it further

**RESOLVED**, that the Village Clerk is hereby directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Village of Caledonia, to give due notice of the adoption of said Local Law to the Secretary of State, and within thirty (30) days of the effective date of this Resolution, to file a report of the final action the Village Trustees have taken with the Livingston County Planning Board. **Timothy Nothnagle** – discussion regarding a letter from Mr. Nothnagle's attorney Peter Skivington. Mr. Nothnagle owns a lot on Iroquois Road in the Town of Caledonia near the golf course. He would like to tap into the private water line that serves the mobile home park. DPW Superintendent Chris Buckley stated that he is not against the connection. However, the village cannot give approval to move forward. The lot is in the town, not village, and the park owners Iroquois Road LLC, are the only parties that can approve the connection to tap into their line. One water invoice will continue to be provided for the 99 mobile home units and Mr. Nothnagle's home.

**2013 Caledonia Fire District Lease** – a **motion** was made by Trustee O'Donoghue to approve Mayor Caluorie to execute the 2013 agreement with the Caledonia Fire District for a monthly rental fee of \$1,200; Trustee Polo seconded the motion.
