Caledonia Library – New members of the Library Board were present to introduce themselves to the Village Board. Present was Cenna Clements, Joan Robinson, Gail Milner, Don MacKay and Librarian Renate Goff. All members were not able to attend. There will be an Open House at the library on Wednesday, August 30th from 6:30 to 8:30 p.m.

Bill Schegg – 2935 Main Street. His property had been used as a taxidermy and gun shop from 1989 to 2014. The property was listed several times with no buyers. Tk Automotive was interested in purchasing it to be an ATV dealer. The current Light Industrial zoning does not allow for this. At this time, TK Automotive is no longer interested in the property. Mr. Schegg met with the Planning Board who recommended a rezone to R2 if he wanted to tear down the building and leave the home. They informed Mr. Schegg that B-2 zoning would be considered spot zoning in this area. The Village Board agreed. A recommendation was made to apply for use and upon denial from the Code Enforcement Officer, Mr. Schegg would be sent to the Zoning Board to seek a Conditional Use Variance.

Justice Mark Riggi discussed the Village Court thanking his Clerk Julie Molisani for all her hard work. The court would like to apply for a JCAP grant to remodel the witness stand base. The cost would be no more than \$3,800. Trustee Grant-Fletcher performed the annual court audit of books. Hamilton Park Renovation Project – Mayor Davis discussed a project Joshua Ingersoll and Jackie Carson plan to lead. It will be a community-driven and funded renovation project to repair and improve the park's facilities. Mayor Davis and Chris Buckley met with them to discuss what items will be updated. The pavilion will be improved, including the bathrooms, storage and arts/crafts area. A new swing set will be installed. Upgrades will be made to the pool fountain. The total project is estimated at \$20,000. On October 7th there will be an all-day fundraiser event at Hamilton Park with current and prior Recreation Park Supervisors and Aids and the community.
