Parks discussion – Trustee Janet Cappotelli, Recreation Director Josh Shelton and Recreation Chairperson Betty McClenney discussed park cleanliness. One option was to have the Aids and Supervisors start prior to opening day cleaning and painting getting the grounds ready for use. Josh Shelton will work on budget figures for the cost to employee them for that period of time. Trustee Cappotelli will work on forming a park committee to provide fundraising. Also discussed was replacing the old equipment one year at a time. Mayor DiLiberto and Trustee Cappotelli both had contacted the Town of Wheatland Recreation Department. Wheatland has a program fee schedule for before, after and during program costs. Trustee Cappotelli will further look into this.

Submitted were Budget Status Reports for General, Water, Capital and Trust & Agency Funds, a list of revenues and expenditures, the Financial Report, Department Supervisors payroll and contractual expense reports, the Water Reconciliation Report & Tax Reconciliation Report. Barry Ganzhorn presented the July Matthews-Mackay Park Report. \$50 was received from a resident for an animal control donation. Barry presented an option for deer control in the village. Barry suggested the Village Board amend the current fence law to allow for the installation of cattle fence at an 8 foot height. Currently the ordinance allows up to 6 feet. Cattle's fencing is welded or barbed wire typically used to

deter cattle from crossing a path and is see-through. Barry thanked the board for their consideration. A **motion** was made by Trustee Cappotelli to accept the report; Trustee Boilard seconded the motion.

Water & Street Superintendent Chris Buckley presented the July DPW Report.

6,727,000 gallons of water was pumped. Daily average is 217,000. Bacteria samples were both negative. New meters continue to be installed on Sand Hill and Middle Road. Water hydrants are being painted and 20 stake outs were performed. Graney Road driveway aprons and topsoil is finished. A 24" pipe and catch basin was installed on Technology Drive and Center Street. An 18' pipe was also installed across Center Street. Trees were trimmed on North Meadows Drive, Spring Street and Grand Circle. Maintenance continues on equipment and parks. A **motion** was made by Deputy-Mayor O'Donoghue to accept the report; Trustee Byrnes seconded the motion.

All police officers have completed their firearms training for the year. Chief Chapman is coordinating a county wide Peer Support Group.
