# Village Board Meeting Minutes December 4, 2018

The Village of Caledonia Board of Trustees held a meeting on Tuesday, December 4, 2018 at 6:30 p.m. at the Village Office.

Alan Garrett – discussed Tree City USA which is a nationwide movement that provides the framework for communities to manage and expand their trees. There are four standards to become eligible. 1) form a tree board 2) tree care ordinance 3) a community forestry program with an annual budget of at least \$2 per capita and 4) An Arbor Day proclamation and observance. The celebration is always held the last Saturday in April. The next one is April 27, 2019. Alan suggested a Focus Group be created. Trustee Cappotelli will work with Alan on the community event.

**Mayor DiLiberto** – discussed the Urban Forestry Grants awarded statewide. Numerous surrounding communities received funding: Village of Scottsville \$22,500, Town of Geneseo \$21,124, Village of Avon \$68,500. The grant does not require matching funding. Mayor DiLiberto would like to apply to the program the next time offered.

#### Barry Ganzhorn presented the Matthews Trail – MacKay Park November Report.

Annual donations were made to the Big Springs Museum and Caledonia Library. \$20 goes to each every December from the MacKay Park account. Barry detailed a suggestion to the theft of signs at the MacKay Park. Plexiglas cut into small pieces, each numbered, will be attached to trees. At the entrance of the trail, informational packets will be available. As visitors tour the trail, they will use the informational packet to detail each sign they come upon. The board was in favor of it and permitted Barry to continue with the new process. Barry then showed the board the green MacKay book and stuffed animal raccoon that were part of a past fundraiser. Barry is researching a company to reprint the book and plans to order more raccoons. Together they would sell for around \$15. Trustee Cappotelli would like to help Barry get order forms out to the school children. A **motion** was made by Deputy-Mayor O'Donoghue to accept the report; Trustee Byrnes seconded the motion.

#### Application of an Easement

WHEREAS, The Village of Caledonia ("Village") is the owner of a certain parcel of land located on Mill Street in the Village of Caledonia, Livingston County, New York and Village intends to construct, maintain, repair and/or replace a culvert on such parcel; and

WHEREAS, Village will request an easement over a portion of a certain parcel of land owned by New York State Department of Environmental Conservation ("DEC") located on Mill Street in the Village of Caledonia, Livingston County, New York, which is described on Schedule "A" (the "Easement Area"); and

WHEREAS, DEC requires that the Village make an application to the DEC requesting an easement over the Easement Area;

WHEREAS, DEC requires that prior to the submission of the application, that the Village approves the application; and

It is hereby resolved by the Village Board of Trustees of Caledonia in the County of Livingston and State of New York as follows:

- **1.** It is hereby ratified that the Village apply to the DEC for an easement over the Easement Area.
- 2. The Mayor of the Village is hereby authorized to complete and sign such application and to take all other actions necessary to obtain an easement over the Easement Area from the DEC.
- 3. This resolution is to take effect immediately.

UPL01719 Description of Permanent Easements to be conveyed by the DEC to the Village of Caledonia County of Livingston.

ALL THAT TRACT OR PARCEL OF LAND situate in Township 1, Range 1 of the Phelps and Gorham Purchase West of the Genesee – Mill Yard Tract, the Village of Caledonia, Town of Caledonia, County of Livingston and State of New York more particularly bounded and described as follows:

COMMENCING at a point on the northerly bounds of Mill Street (33-foot-wide right of way) at P.C. Station 6+04.84; thence easterly along the northerly bounds of Mill Street on a curve to the left, with a radius of 1893.36 feet, for a distance of 102.09 feet to the southwest corner of lands of the People of the State of New York (Liber 158 of Deeds, Page 153) and the true point of BEGINNING of the parcel herein described; thence N 07° 48' 35" W and along the westerly bounds of lands of said People of the State of New York for a distance of 23.23 feet to a point; thence through the lands of the People of the State of New York the following three (3) courses and distances:

- 1. N 90° 00' 00" E for a distance of 10.17 feet to a point marked by a rebar set;
- 2. S 00° 00' 00" E for a distance of 10.58 feet to a point marked by a rebar set; and
- 3. N 85° 55' 13" E for a distance of 38.89 feet to a point marked by a rebar set in the easterly bounds of said lands of the People of the State of New York; thence S 07° 48' 35" E and along the easterly bounds of said lands of the People of the State of New York for a distance of 12.02 feet to a point marked by a rebar set in the northerly bounds of Mill Street: thence westerly along the northerly bounds of Mill Street on a curve to the right, with a radius of 1893.36 feet, for a distance of 47.55 feet, said curve being subtended by a cord of S 86° 01' 39" W, to the point or place of beginning.

CONTAINING 675 square feet or 0.016-acre parcel of land, be the same more or less.

ALL AS SHOWN on a map entitled "Map Showing a Permanent Easement to be Acquired by the Village of Caledonia Pursuant to Subdivision 2, Section 3, Article 2 of the Public Lands Law, Project: Livingston 45.01, Located on: Mill Street at the Big Springs Area of the Caledonia Fish Hatchery Property," dated November 29, 2017, prepared by Landtech Surveying and Planning P.L.L.C. and filed in the Offices of the Department of Environmental Conversation in Albany, New York as Map No. 12,623, said map also being filed in the Office of General Services in Albany, New York as OGS Map No. 2649.

**RESOLVED,** that the Village Clerk is hereby directed to enter said Local Law in the minutes of this meeting and in the Local Law Code Book of the Village of Caledonia, and to give due notice of the adoption of said Local Law to the Secretary of State.
