Village Board Meeting Minutes February 6, 2018

The Village of Caledonia Board of Trustees held a meeting on Tuesday, February 6, 2018 at 6:30 p.m. at the Village Office.

Clerk-Treasurer Ann Marie Grattan presented the January Clerk Report.

Submitted were Budget Status Reports for General, Water, Capital and Trust & Agency Funds, the Financial Report, Department Supervisors payroll and contractual expense reports and the Water Reconciliation Report. A **motion** was made by Deputy-Mayor DiLiberto to accept the report; Trustee Grant-Fletcher seconded the motion.

DPW Superintendent Chris Buckley presented the January DPW Report. Barry presented certificates of appreciation to donors who supported the MacKay Wildlife Preserve. The Gigglin Pig, Five Star Bank and Tompkins Bank of Castile donated picnic tables and trees. Barry asked the Village Board if the village insurance company NYMIR was contacted regarding putting a swing set at the MacKay Park. Chris Buckley discussed the existing violations and the cost to fill engineered wood mulch around the swing set area. The same would have to be done at the MacKay Park. It was decided to not add a swing set to the MacKay Park. Barry took a moment to thank Mayor Davis, Trustee Grant-Fletcher and Trustee Nothnagle for their support the past 4 years. A motion was made by Trustee Grant-Fletcher to accept the report; Trustee Nothnagle seconded the motion.

DPW Superintendent Chris Buckley presented the January DPW Report. Both water bacteria tests were negative. Service leaks were repaired at 2952 Main Street and 261 Spring Street. Three hydrants were repaired for leaks and NYS Leak surveyed the entire system. New digital water meters continue to be installed. Snow and ice removal continues and salt used to date is 136 tons. Drainage issues on Graney Road continue to be worked on. An oak tree stump was removed and a ditch line reconstructed. There are 4 driveway pipes left to replace. Chris discussed a problem on Mill Street with tractor trailer trucks using the route most likely from GPS mapping. According to the village code book there is no weight limit on Mill Street. To prevent the newly paved road from damage, Chris & Ed Russell will look at code options through a local law update. A motion was made by Trustee Grant-Fletcher to accept the report; Deputy-Mayor DiLiberto seconded it.

Deputy-Mayor DiLiberto presented the January Police & SRO Reports for Chief Chapman. There were 75 calls for service, 32 traffic tickets issued, four Town of

Caledonia assists, one accident report and three arrests. There was a drug arrest for a full-house of marijuana. Also, a drug bust of cocaine sales at the A-Plus and other targets pending for the Drug Task Force. The January SRO Report included 18 district requests for police services, nine out-of-building assists to the Caledonia Police Department or other agencies and four arrests. There were two drug task force arrests, one federal arrest warranted served with Homeland Security, ambulance/ems calls and one DOA. A suspicious male was reported around North Street during student dismissal. The Rapid Response System was updated. A suspicious male was reported near State Street and Park Place during the time students were exiting the school bus. District requests included monitoring dismissal, review camera footage, vehicle lockouts, government class questionnaires, found property, escorting students off of campus, suicidal students, Child Protective Services incidents and a hazing incident. A **motion** was made by Trustee Grant-Fletcher to accept the report; Trustee Nothnagle seconded the motion.

Mike Murphy presented the Code Enforcement Report for January. Permits were issued for a deck/fence, porch/deck and alteration on an apartment remodel. Preliminary discussions have begun regarding a car sales lot on State Street and a new building/driveway at the NYS Fish Hatchery.
