#### Village Board Meeting Minutes November 6, 2018

The Village of Caledonia Board of Trustees held a meeting on Tuesday, November 6, 2018 at 6:30 p.m. at the Village Office.

#### **Public Open Forum:**

Georgianne Shultz, 3133 LeHigh Street – discussed unsightly conditions at her neighbor's home and an unlicensed vehicle. Ms. Shultz presented pictures to the board of their yard. Code Enforcement Officer Michael Burnside will address the matter.

CHS Mobile Integrated Healthcare – new ambulance providers of Caledonia. Reg Allen, Chief and Jim Bucci, Deputy Chief introduced themselves to the Village Board and discussed the most recent Quarterly Report for the Village of Caledonia. They explained call volume, coverage and response performance. The ambulance bay is moving from State Street to temporary housing at the Mumford Fire Department. The Village Board thanked them for coming in and for their service.

Officer Jared Passamonte presented the October Police & SRO Report. There were 68 calls for service, 35 traffic tickets issued, five Town of Caledonia assists, two accident reports and five arrests. Officer Passamonte worked a week with Homeland Security on the Counter Terrorism Zone 11 Red Team. Exercises took place in Livingston and three surrounding counties. Red Team exercises are designed as covert operations to provide realistic pictures of counter terrorism. The Caledonia Police assisted the Livingston County Sherriff's Office with a man with a gun and hostages. Halloween night was quite and uneventful. The October SRO Report includes 20 district requests for police service,

four out-of-building assists, six classroom visits and three emergency drills. A **motion** was made by Deputy-Mayor O'Donoghue to approve both reports; Trustee Boilard seconded the motion.

## Water & Street Superintendent Chris Buckley presented the October DPW Report.

Bacteria samples were both negative. New meters continue to be installed. Meter vaults were cleaned and prepped for the winter. A curb stop was repaired at the cemetery and at

Hamilton Park. A sidewalk on Main Street was repaired and added asphalt at the commons parking lot where the sign electric was installed. All parks are winterized and closed and building maintenance performed. Chris discussed obtaining a quote for roof repairs above the fire hall, police department and court clerk's office. This item will be added to the December agenda for further discussion. A **motion** was made by Trustee Cappotelli to accept the report; Trustee Byrnes seconded the motion.

Michael worked with the Livingston County 911 Center verifying addresses in the village and met with the Caledonia Library Board regarding set backs for their proposed building project. Michael completed classes "Introduction to Code Enforcement Practices II". A motion was made by Trustee Cappotelli to accept the report; Trustee Byrnes seconded the motion.

RESOLVED, that the Mayor of the Village of Caledonia is hereby authorized to sign a joint services agreement, the format of which is attached to this resolution, with any town in Livingston County and Livingston County.
