Police Chief Dan Chapman presented the Police & School Resource Officer Report for January. Chief Chapman starts a new job on February 11th as Fisher's Fire Chief. Officer Passamonte is being trained on administrative duties. An arrest was for sending inappropriate photo's to a minor. A separate sex abuse report is being investigated with the assistance of Justice for Children Advocacy Center of Batavia. Anonymous emails continue to be received about alleged drug activity at the bowling alley; an investigation in ongoing into the matter. Chief Chapman would like to sponsor Matthew Adams for the police academy. The SRO Report includes 14 district requests for services, 14 assists to other agencies, one arrest and four emergency drills. Investigated two traffic incidents. Attended meetings with administrators and local Fire Chiefs for traffic control at graduation. A motion was made by Trustee Boilard to accept the reports; Trustee Cappotelli seconded the motion.

The National Grid LED light conversion is underway. The new weight limit signs for Spring and Mill Street are in. Several truck repairs were needed for both plow trucks. WHEREAS, said public hearing was duly held on February 5, 2019 at the Caledonia Village Hall, 3095 Main Street, Caledonia, New York, and all parties in attendance were permitted an opportunity to speak on behalf or in opposition to the Proposed Local Law, or any part thereof, and

WHEREAS, the Board of Trustees, after due deliberation, finds it in the best interest of said Village to adopt Local Law No. 1-2019.

NOW THEREFORE BE IT RESOLVED, that the Board of Trustees of the Village of Caledonia hereby adopts said Local Law No. 1 of 2019 a Local Law authorizing a property tax levy in excess of the limited established in General Municipal Law §3-c.

RESOLVED, that the Village Clerk is hereby directed to enter said Local Law in the minutes of this meeting and in the Local Law Code Book of the Village of Caledonia, and to give due notice of the adoption of said Local Law to the Secretary of State.

RESOLVED, that the Police Chief is hereby authorized to reside in a locality situated beyond the 15 minutes' commuting time by motor vehicle otherwise required by Village Code Section 45-6, Article IV C Standards.
